## **BUILDING BY-LAWS**

- 11.-(1) An approved plan may be inspected in the office of the local authority subject to the payments of the prescribed fee.
- (2) An approved plan may be copied in the office of the local authority subject to the applicant submitting with his application to copy such plan the written consent of the owner of the building.
- (3) The fees payable shall be as follows -

### **AMENDMENT ON BUILDING BY-LAW, 2001**

Inspection, copying and certification of prescribed *Forms A, B, C, D, E, F, G, H & I.*

- 18-(1) Any prescribed form in Schedule B which has been submitted to the local authority or which has been issued by it, as the case may be inspected and copied in the office of the local authority on payment of the following fees:-

- (2) The fees for an endorsement by the local authority to certify any copy of a prescribed form in Schedule B which has been submitted to the local authority or issued by it as a true copy, shall be *RM 20.00 per form.*
